

# Privacy Policy

This Privacy Policy ("Policy") applies to [www.beyondthebooksvbp.com](http://www.beyondthebooksvbp.com), and Beyond the Books LLC ("Company") and governs data collection and usage. The Company's website is a virtual business services site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

## Sharing Information with Third Parties

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest
- Enable solely internal uses that are reasonably aligned with your expectations based on your
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with
